Dear Secretary McDonald:

We write to express our concerns regarding the Interim Final Rule - Expanded Access to Non-VA Care Through the Veterans Choice Program (Docket ID: VA-2014-VHA-0022).

P.L. 113-146, the Veterans Access, Choice, and Accountability Act of 2014, directed the Secretary of Veterans Affairs (VA) to establish a temporary program (Veterans Choice Program) to furnish hospital care and medical services through non-VA health care providers to veterans who either cannot be seen within the wait-time goals of the Veterans Health Administration or who qualify based on their place of residence. Additionally, the law gave the Secretary of the VA the flexibility to determine the eligibility of a veteran for the Veterans Choice Program if the veteran “faces an unusual or excessive burden” in accessing a VA medical facility.

On November 5, 2014, the VA issued an Interim Final Rule that defines the parameters of the Veterans Choice Program, and clarifies aspects affecting veterans and the non-VA providers who will furnish hospital care and medical services through the Veterans Choice Program.

While we were pleased that the rule making process proceeded in a timely fashion, we are concerned that the Interim Final Rule establishes a very narrow interpretation of the geographic-based eligibility criteria with regard to a veteran’s residence. Most notably, the 40 mile distance is measured from a veteran’s residence to any VA medical facility, even if that facility cannot provide the care that the veteran requires. We believe this strict interpretation severely limits the eligibility of veterans and runs counter to the intent of the Veterans Choice Program, which is to ensure timely access to high-quality health care services and to provide a temporary relief valve on the VA to allow it to increase its own capacity to provide care. We respectfully request that you reconsider this position, for as you stated before the House Veterans Affairs Committee on February 11, 2015, when asked a question about this particular interpretation by Rep. Huelskamp, “I agree with your point of view that distance from a place you can’t get the service seems like a relatively weak measure...”

We strongly encourage you to utilize, to the maximum extent allowable, the authority provided to you through the law to define a veteran facing "an unusual or excessive burden" in accessing a VA medical facility.

Specifically, we urge you to reconsider travel time as well as total distance to a medical service offered at a VA medical facility, rather than simply the distance to any VA medical facility. Many of the veterans in our Congressional Districts have to travel distances that significantly exceed 40 miles in order to access certain specialty care or inpatient services. Further, due to traffic congestion in many of our districts, the driving times for these trips are unpredictable. These distances and times are further exacerbated by the fact that many of our veterans rely on shuttle transportation. This is an incredibly frustrating experience for older infirmed veterans, as local non-VA hospital care and medical services are readily available.


